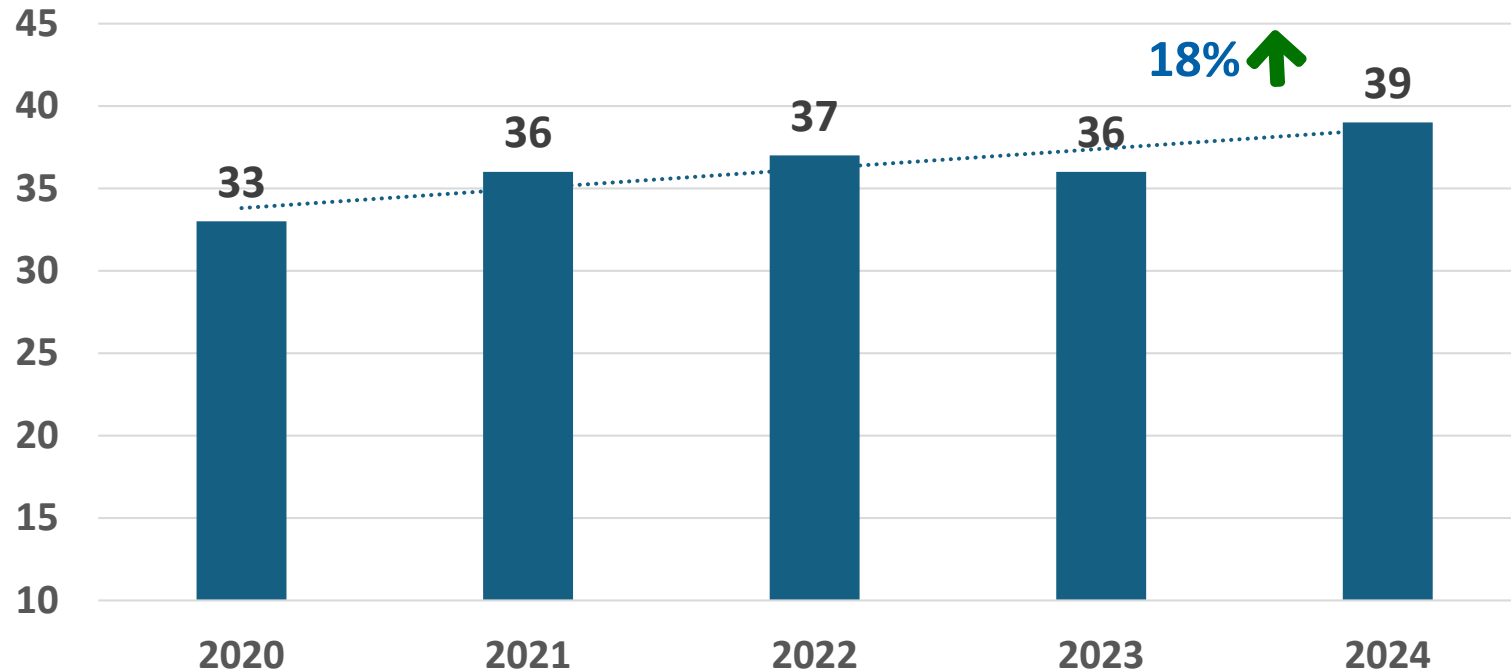


Helicopter Incident

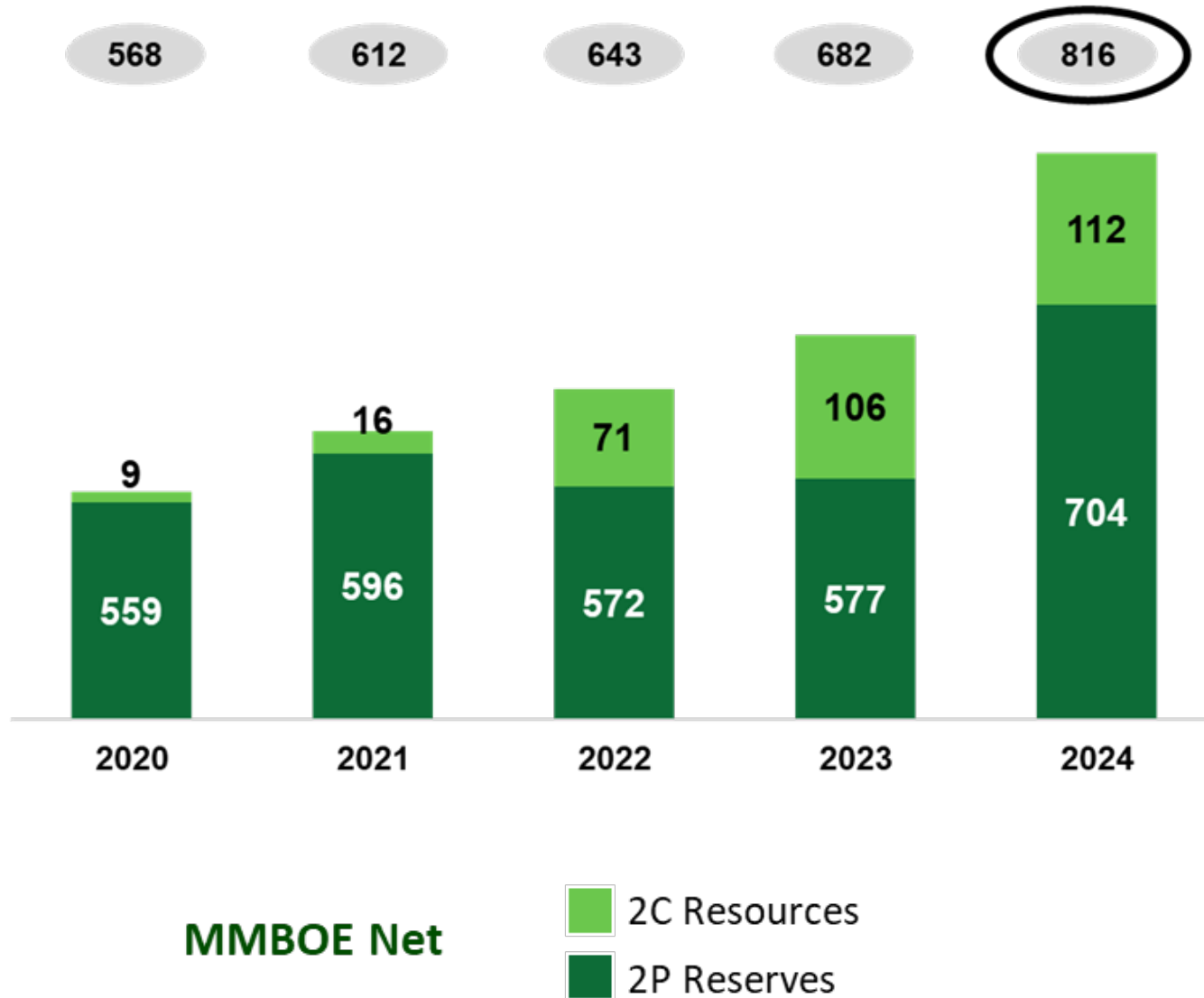

Ghazij Appraisal & Development

- One Exploratory and 4 Appraisal wells drilled and put on production

- Ghazij-7 Development well has been drilled and testing is in progress.



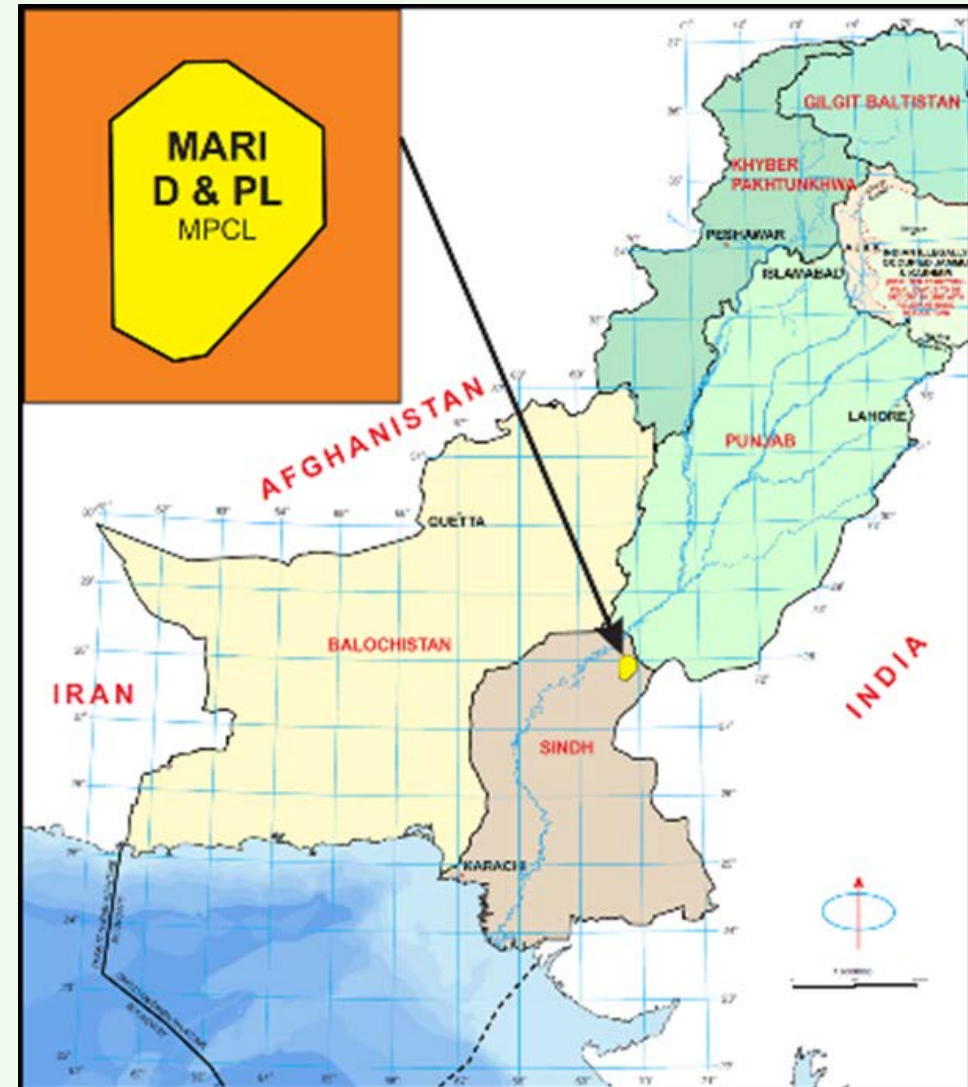
Shewa EPF Waziristan Block

- The work on EPF and SNGPL pipeline has been completed
- Pipeline Hydro testing of the remaining section is under process.
- Security situation and local dynamics will dictate the production commencement.



Mari D&P lease

- Mari D&P lease has been renewed for five years until November 2029 With an additional 15% payment of wellhead value
- With latest amendments in the Petroleum Policy 2012, the lease can now be extended till economic viability of the Field.

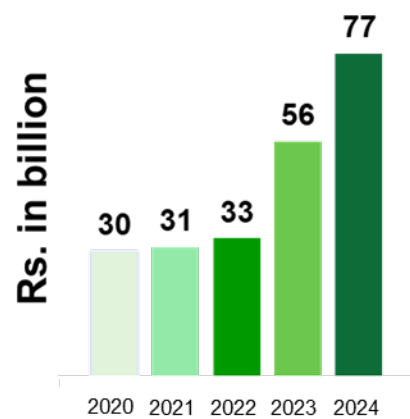

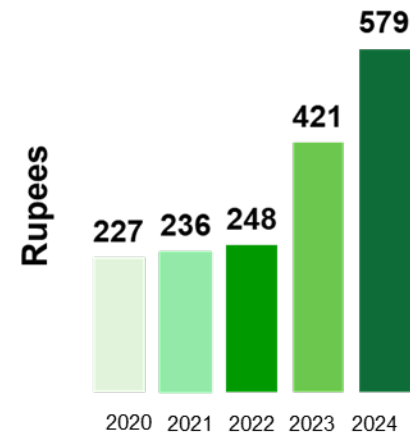

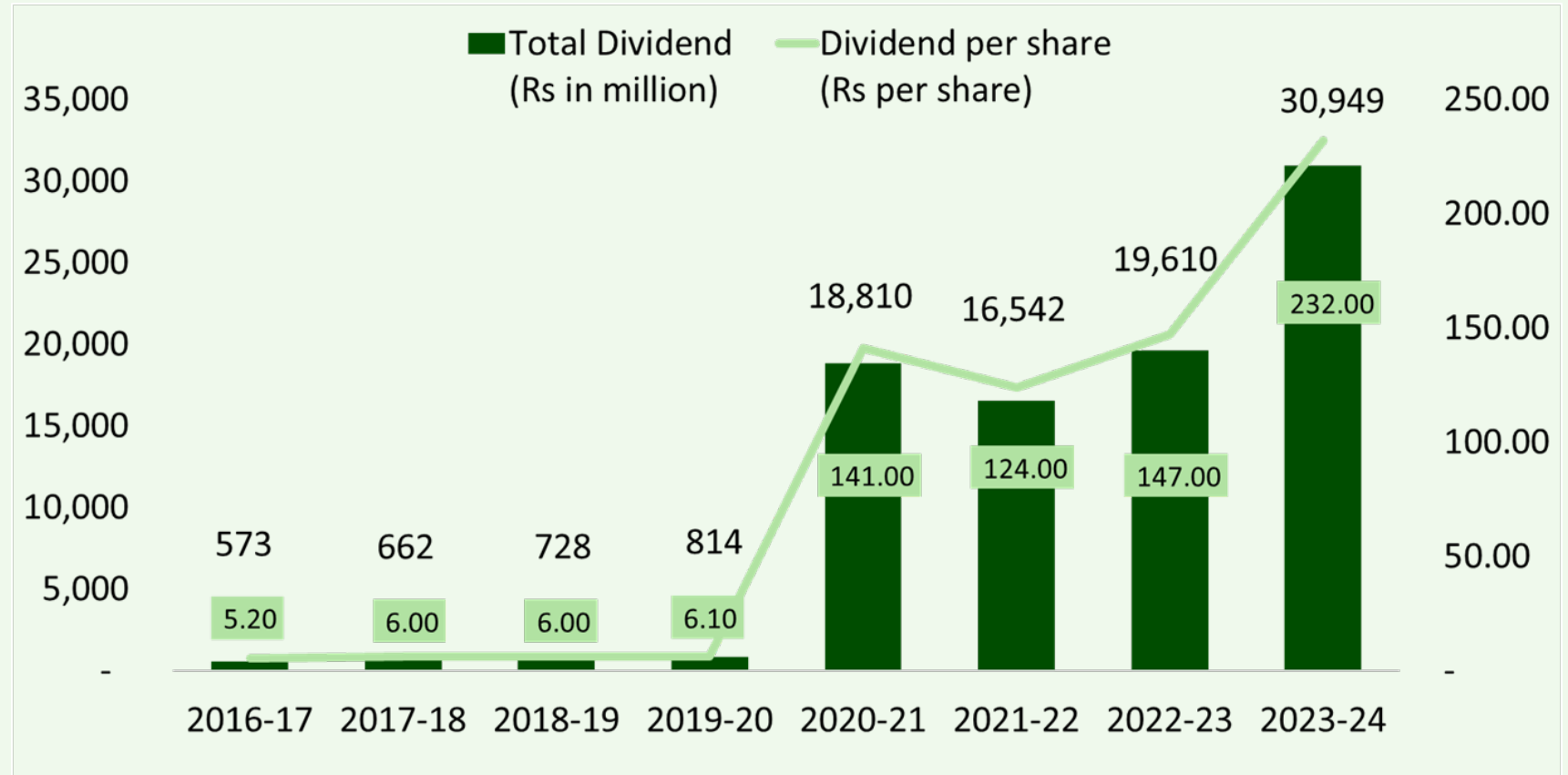
