Subject: Fraudulent Usage of name of IGI Finex Securities Limited on Social Media Platforms/WhatsApp Groups

Dear Sir,

With reference to the subject matter, we, IGI Holdings Limited being the holding company of IGI Finex Securities Limited (a wholly owned subsidiary of IGI Holdings Limited), hereby notify that it has come to our attention that unauthorized individuals have created fake and misleading social media platforms/WhatsApp groups under the name “G45 IGIL Securities Discussion,” impersonating IGI Finex Securities Limited. We would like to categorically state that these groups are NOT in affiliation with or endorsed by IGI Finex Securities Limited, its associated companies or its holding company - IGI Holdings Limited. We are actively investigating this matter and have already initiated legal actions to address false usage of name of IGI Finex Securities Limited.

Additionally, a fraudulent mobile application titled “IGIL” has been published on Google Play Store, falsely representing IGI Finex Securities Limited. This app is not authorized by IGI Finex Securities Limited, its associated companies or its holding company - IGI Holdings Limited. IGI Finex Securities Limited has also notified of the fraudulent activity by publishing a Public Notice on its website attached herein as “Annexure A”.

We intimate all investors and general public to please verify the authenticity of any social media platforms/WhatsApp groups and/or accounts claiming association with IGI Finex Securities Limited, its associated companies or its holding company - IGI Holdings Limited before taking any investment and / or monetary decisions and to take necessary precautionary steps for identification of person(s)/company involved therein. If in doubt, please contact IGI Finex Securities Limited on 021 111 444 001 directly to confirm any communications.

Any material information will be disclosed to the stakeholders when deemed necessary in accordance with the laws and regulations applicable to IGI Finex Securities Limited, its associated companies or its holding company - IGI Holdings Limited.
