In accordance with Sections 96 and 131 of the Securities Act, 2015 and Clause 5.6.1 of the Rule Book of the Pakistan Stock Exchange limited ("PSX"), and with reference to our earlier letters dated October 31, 2024 Shell Pakistan Limited ("Company") hereby conveys the following information.

On October 31, 2024, the acquisition by Wafi Energy Holding Limited of 187,866,141 ordinary shares (representing approximately 87.78% of the total issued share capital) of the Company, through the Share Purchase Agreement dated 31 October 2023 ("SPA") and a Mandatory Tender Offer to the remaining shareholders of the Company as required under the Securities Act, 2015 and Listed Companies (Substantial Acquisition of Voting Shares and Takeovers) Regulations, 2017, was completed.

Pursuant to the acquisition, on November 27, 2024, the members of the Company resolved to change the name of the Company from 'Shell Pakistan Limited' to 'Wafi Energy Pakistan Limited'.

The Company is pleased to inform that the Securities and Exchange Commission of Pakistan has issued a Certificate of Incorporation on Change of Name dated January 13, 2025. Consequently, the Company's name has changed from 'Shell Pakistan Limited' to 'Wafi Energy Pakistan Limited' with effect from January 13, 2025. A copy of the Certificate of Incorporation on Change of Name is enclosed herewith.
