The Independent Directors possess diverse experience, expertise, and relevant knowledge and skills. They also comply with the provisions of Section 166 of the Companies Act and the Companies (Manner and Selection of Independent Directors) Regulations, 2018.

As the number of candidates in the "Female Director" and "Independent Directors" categories are equal to number of seats fixed by the Board, they shall be deemed to have been elected unopposed in the said categories at the forthcoming EOGM.

However, in the "Other Directors" category, the number of candidates standing for election is five (05), which exceeds the number of seats fixed by the Board in that category (four 04). Therefore, an election will be conducted for the "Other Directors" category only at the forthcoming EOGM. Number of Votes would be equal to number of voting shares held multiplied by the number of directors to be elected, i.e. four.

In accordance with the Companies (Postal Ballot) Regulations, 2018, members will be entitled to exercise their voting rights for this category of Directors as per the provisions outlined in the regulations.

Riaz Ahmad & Co., Chartered Accountants, the Company's external statutory auditor, has been appointed as the Scrutinizer, possessing the requisite knowledge and experience to independently scrutinize the voting process for the election of Directors.
