NEW YORK (News Wire): Hollywood actor **Rourke** has been given a formal warning using "offensive and unacceptable" language towards **Jojo Siwa** in **Celebrity Big Brother**. The Oscar-nominated star entered the **ITV** show on Monday alongside the 21-year-old and social media personality, and other celebrities. Siwa accused Rourke, 72, of being "homophobic" for saying he was "going to get the lesbian out real quick" and making comments about her sexuality. As a result, **Big Brother** told him, "Further language of this nature could lead to your removal from the **Big Brother** house."
