# Request for Extension in release of Nine-Monthly Accounts for the period ended March 31, 2025

This is with reference to Section 237 of the Companies Act, 2017, which mandates companies to prepare and circulate quarterly financial statements within thirty days of the close of the third quarter.

In connection with the Annual Financial Statements for the financial year 2023-24, it is apprised that the Oil and Gas Regulatory Authority (OGRA) issued its decision on the Company's Final Revenue Requirement (FRR) on March 28, 2025. The Company is currently in the process of finalizing its financial statements, which are expected to be approved by the Board of Directors in the last week of April 2025. The Annual General Meeting (AGM) of the Company is scheduled to be held in the third week of May 2025, wherein the appointment of statutory auditors for the financial year 2024-25 will also be undertaken.

It may further be noted that the Half-Yearly Financial Statements are subject to a Limited Scope Review by the statutory auditors. Accordingly, the auditors for FY 2024-25, once appointed in the upcoming AGM, will require reasonable time to carry out the limited review of the Half-Yearly Financial Statements for the period ended December 31, 2024.

In light of the above and the legitimate constraints faced by the Company, it is respectfully requested that the Commission may kindly grant an extension of 60 days from the date of the AGM for the circulation of the Nine-Monthly Accounts for the period ended March 31, 2025. The Half-Yearly Financial Statements (subject to limited review) and the Third Quarter Financial Statements shall be released simultaneously.

We shall be grateful for your kind consideration and approval of our request.
