

## MATERIAL INFORMATION

In January 2016, the Securities and Exchange Commission of Pakistan (SECP) filed a petition under Companies Jurisdiction in the Honorable High Court, through Judicial Company Matter, against the Company. The petition sought directions from the Honorable Court to compel the Company to repurchase its shares from minority shareholders.

Upon review of the Company's submissions and supporting documentation, the Honorable High Court was pleased to accept the Company's position. Consequently, the Court dismissed the petition filed by the SECP as infructuous, vide Order dated April 29, 2025.
