The Shareholders are therefore requested to register themselves to the eService facility of CDC through above mentioned eService portal to avail the said facilities.

The Shareholders who have not yet provided copies of their valid CNICs and designated bank account details (IBAN) are again requested to provide such information. In case of book-entry securities, in Central Depository System (CDS), the said information should be provided/updated to CDS Participations and in case of physical securities, to Share Registrar, M/s.
