**NOTES:**

1. The share transfer books of the company will remain closed from June 22, 2025 to June 30, 2025 (both days inclusive).
2. In terms of section 159 of the Companies Act, 2017 any member who seek to contest an election to the office of the director shall whether he/she is a retiring director or otherwise, file with the company, not later than fourteen (14) days before the meeting at which election are to be held the following documents: a notice of his/her intention to offer himself for election as a director along with consent to act as director u/s 159 (4) of the Companies Act, 2017.  
Notice of his/her intention to offer himself/herself for election as Directors in terms of Section 159 of the Companies Act, 2017. The candidate should also conform that:
  - (a) Neither he / she nor his / her spouse is engaged in the business of brokerage or is a sponsor, Directors or Officers of a corporate brokerage house.
  - (b) He/she is not serving as a Director in more than seven listed companies simultaneously, provided that this limit shall not include the directorship in the listed subsidiaries of a listed holding company.
  - (c) Consent to act as director in Form 28.
  - (d) A detailed profile / curriculum vitae of the candidate.
  - (e) Signed declaration in respect of being compliance with the requirements of the Code of Corporate Governance, 2012 are the eligibility criteria as a set out in the Companies Act, 2017 to act as director of listed Company.
3. A member entitled to attend, speak and vote at this meeting may appoint a proxy to attend and vote on his/her behalf. A proxy must be a member of the Company. Any individual beneficial owners of CDS, entitled to attend and vote at this meeting, must bring his/her Original CNIC, CDS account and participant's I.D. Nos. In case of proxy must enclose attested copies of his/her CNIC, CDS account and participant's I.D. Nos. Proxies in order to be effective must be received at registered office of the company not less than 48 hours before the date of this meeting.

**1. Statement made under section 166(3) of the Companies Act, 2017 in respect of appointment of Independent Directors.**
