

KEY HIGHLIGHTS



Strong financial performance despite reduction in volumes

Despite a 1.7% reduction in volumes, the Company delivered strong profitability, with operating profit rising 12.8% to PKR 31.8 Bn, and higher dividend payout of 340% compared to 260% last year.

Further expansion in solar power generation


From 105.45 MW (June 2024) to 112.23 MW (June 2025)

resulted in Bestway retaining its position as the market leader in 2025, despite the economically challenging environment.


CAPACITY UTILISATION- CEMENT





INDUSTRY GROWTH (BCL VS INDUSTRY)






BESTWAY CEMENT MARKET SHARE - LOCAL

(BASED ON DISPATCHES)




BCL VS INDUSTRY



FINANCIAL PERFORMANCE





- •Net revenue increased by 3.8 billion i.e. 4%.
 - •Volume Impact: Sales volumes decreased by 0.12MT (-2%)
 - •Retention Impact: Net retention increased by 5%.
- •Cost of sales: Cost per ton remained same. Decrease in cost is due to decrease in sales volume by 2%.
- •Gross profit: Our GP % increased to 35% vs 31% for the same period last year.

- **Finance cost** decreased due to significant decrease in interest rates and lower borrowings.
- Other income primarily increased due to increase in share of profit from associated company(FY25:9.61% FY24:8.17%)
- Income tax expense increase is profit based.

Opportunities

- Govt housing & infrastructure to boost domestic demand
- Industry dispatches up 21% in 2M
 FY26 (Local +14%, Exports +51%)

Challenges

- High taxes, duties, royalties
 & energy costs weighing on profitability
- Export uncertainty, particularly due to border issues with Afghanistan
- Recent floods likely to put pressure on the economy

Bestway Strategic Positioning

- Financially resilient & operationally efficient to sustaining profitability under pressure
- Better positioned to withstand headwinds and capture growth opportunities
