Crackdown launched against smoke-emitting vehicles

The Department of Transport, Khyber Pakhtunkhwa, under the special directives of the Secretary and Director Transport, has launched an effective province-wide crackdown against buses and vehicles emitting toxic and environmentally harmful smoke.

During the past two weeks, a total of 7453 vehicles were inspected across the province. Out of these, 4,352 vehicles passed the emission test, while 3,301 drivers were fined and instructed to obtain a Vehicle

laboratory, the emission levels of the buses are tested, while the MVE team inspects tyres, seats, body condition, brakes, and other fitness standards. Buses found emitting smoke beyond international limits are directed to obtain a valid fitness certificate from VETS before resuming operations.

According to VETS officials on Thursday, during the past three days, detailed inspections were conducted on school buses operating along Warsak Road, Darsak Road and surrounding areas. So far, 40 buses have been checked, among which only 5 met international emission standards, while the remaining bus

 move if early elections are held after fulfilling all constitutional requirements including the appointment of a new Chief Election Commissioner. PML-N leaders maintain that fresh elections are the only way to ensure political stability in Azad Kashmir. They argue that delaying polls could deepen the crisis and allow misuse of public resources. Sources within the PML-N said the party fears that

the PPP could exploit billions of rupees in government funds for political and electoral purposes. They also expressed concern that the PPP could influence upcoming elections by leveraging thousands of available government jobs in AJK. "If we support the PPP now, we may end up sitting in the opposition again," one senior PML-N member remarked. "Immediate elections are the

only fair solution." On the other hand, the PPP remains adamant about completing its full constitutional term in power. Party sources say the PPP leadership wants the government rather than push for elections. "The PPP believes that stability requires continuity, not confrontation," a party insider told reporters.

 His remarks after face-to-face talks with Chinese President Xi Jinping in the South Korean city of Busan, their first since 2019, marked the finale of Trump's whirlwind Asia trip on which he also touted trade breakthroughs with South Korea, Japan and Southeast Asian nations. "I thought it was an amazing meeting," Trump told reporters aboard Air Force One shortly after he departed Busan, adding that tariffs imposed on Chinese imports would be cut to 47% from 57%.
