This is in continuation of the disclosure made by K-Electric Limited ("Company") on October 21, 2025, it is further informed that the Company has filed an Appeal before the NEPRA Appellate Tribunal under section 12-G of NEPRA Act, 1997 against the decision of NEPRA dated October 20, 2025. Pending consideration of the Appeal by the NEPRA Appellate Tribunal (which is currently nonfunctional), the Company filed Constitutional Petition Nos. D-5384 of 2025, D-5385 of 2025, D-5386 of 2025 and D-5387 of 2025 before the High Court of Sindh at Karachi. In this respect, the High Court has been pleased to pass interim orders on November 04, 2025 to the effect that "no coercive action shall be taken against the petitioner in terms of impugned decision till the next date of hearing".
