No objection against this petition is being received, nor is there any material on record to suggest that the same is contrary to law or in violation of any public interest. Accordingly, the instant Petition is allowed as prayed, and the Scheme of Arrangement is hereby permitted subject to fulfill all legal requirements and formalities.
