
Furthermore, we hereby affirm and confirm as under:

The management of ASIC has reviewed all ongoing operational, financial, and corporate matters of the Company, and no development, transaction, or corporate action has occurred which may reasonably be expected to have a material impact on or influence the market price or trading activity of the Company's shares; and
3. Any movement in the share price and/or trading volume of the Company appears to be market-driven and attributable to general market conditions, investor sentiment, or trading dynamics, rather than to any act, omission, or undisclosed information on the part of the Company.

The Company remains fully committed to maintaining the highest standards of transparency and compliance. In the event that any material or price-sensitive information arises in the future, the same shall be promptly disseminated through PUCARS in strict compliance with Clause 5.6.3 of the PSX Regulations and other applicable laws.
