B. Exercising the Right (Other than CDC)

CDC Participants / LDS Department will issue the copies of the Right Subscription Request (RSR), enabling the investor to make payment through any branch of the banker(s) to the issue.

C. Right Subscription Request

A Right Subscription Request can be initiated for full or partial right offer.

D. Payments

- Payment should be made by cash, crossed cheque, demand draft, or pay order drawn in favor of: "786 INVESTMENTS LIMITED — Right Shares Subscription Account" through any branch of Soneri Bank Limited on or before 09th January, 2026, along with the duly filled and signed Right Subscription Request.

F. Investment in Marketable Rights

Unpaid rights can be bought and sold according to the Right Offer process at Karachi Stock Exchange Limited or any other Stock Exchange as applicable.

PROCEDURE FOR PHYSICAL SHAREHOLDERS

- Unpaid rights issued in physical form can be deposited into CDS as per normal procedure, allowing full tradability before the last date of trading (i.e., 09th January, 2026).
- Account holders may also deposit the rights duly signed and renounced in favor of CDC along with CDS participant and securities deposit forms.

RENUNCIATION & SPLITTING

- Renunciation is allowed during the renounce their Rights should complete the relevant section on Page 3 of the Letter of Rights and submit it to the Company's banker before 09th January, 2026.
- Splitting requests for splitting of Letters of Rights into smaller denominations must be submitted to FD. Registrar Services (PVT) Ltd, Registrar to the Issue, by 23rd December, 2025.
