3. To make long term equity investment of up to Rs. 1,000,000,000 (Rupees One Billion) in proposed JVC (to be incorporated) from time to time within a period of 5 (five) years subject to approval of the shareholders of the Company in terms of Section 199 and other applicable provisions of the Companies Act, 2017.
4. To lease SGFL's piece of land measuring 136,816 square feet together with the building thereon having covered area of 79,760 square feet located at 10 km Muridke-Sheikhupura Road, Muridke, Punjab, Pakistan, to the proposed JVC for a period of one (1) year. Provided that the lease of the building shall be subject to the prior approval of the shareholders of SGFL, as required under Section 183 (3) of the Companies Act, 2017 and related regulations thereon.
