This is in reference to **Section 96 of the Securities Act 2015**, and **Clause 5.6.1 (a)** of PSX Regulations


We refer to our earlier communications concerning the potential change in shareholding of Attock Cement Pakistan Limited ("Company"), and write to provide a further update in accordance with applicable disclosure requirements under the Securities Act, 2015, the Companies Act, 2017, and relevant regulations of the Pakistan Stock Exchange Limited ("PSX").

We have been informed by the **Pharaon Investment Group Limited**, the majority shareholder of the Company that it has entered into a Share Purchase Agreement with **Fauji Cement Company Limited** and **Kot Addu Power Company Limited** for the sale of its **84.06%** shareholding in the Company. We are further informed that completion of the transaction is subject to, inter alia, approval of the Competition Commission of Pakistan and compliance with the Securities Act, 2015, and all applicable takeover laws and regulations of Pakistan.
