**1. THE COMPANY AND ITS OPERATIONS**

Globe Textile Mills Limited (the Company) was incorporated on 17th November, 1967 as a Public Limited Company in Pakistan and registered under the Companies Ordinance, 1984 (the ordinance), [Repealed with the enactment of Comapnies Act, 2017] . Its shares are quoted in Pakistan Stock Exchange. The principal activity of the Company was manufacturing and selling of yarn.
