The Directors of the Company have pleasure in submitting their Report together with the un-audited financial statements of the Company for the half year ended December 31, 2025 duly reviewed by external auditors. During the period under review your Company has earned pre-tax profit Rs. 100.196 (M).

REVIEW OF OPERATIONS

During the period Rs.100.713 million was invested by the Company in the fixed assets for BMR plan to improve the quality. These investments were financed through retained earnings.

EARNING PER SHARE

The earnings per share for the half year ended December 31, 2025 is Rs.1.20 as compared to Rs.15.05 for the previous corresponding period.

FUTURE PROSPECTS

The future outlook of Pakistan's spinning sector remains cautiously optimistic despite continued macroeconomic pressures and structural challenges. As a core component of the country's textile value chain, spinning plays a critical role in export earnings and industrial employment. Pakistan has historically benefited from a strong cotton base and an established yarn export presence in international markets.

However, the sector is facing significant headwinds. A persistent decline in domestic cotton production largely due to climate variability, pest attacks, and shifting crop patterns has increased reliance on imported cotton, raising input costs and compressing margins. Quality inconsistencies in local cotton further affect yarn competitiveness. In addition, subdued global textile demand and strong competition from regional producers such as India and Bangladesh have placed downward pressure on yarn prices and export volumes.

Energy remains one of the most critical constraints for spinning mills. High and volatile electricity and gas tariffs, along with periodic supply disruptions, significantly undermine cost efficiency compared to competing countries. Liquidity challenges exacerbated by delays in tax refunds and limited access to concessionary financing continue to strain working capital across the sector.

Despite these challenges, there are positive developments that could improve long-term prospects. Many spinning units are investing in modern, energy-efficient machinery and renewable energy solutions such as solar power to reduce operating costs and enhance productivity. There is also a gradual shift toward higher-quality and specialty yarns to improve value realization and reduce dependence on commoditized segments.

With consistent government policies, energy tariff rationalization, improved cotton productivity, and continued technological upgrading, Pakistan's spinning sector has the potential to reinforce its competitiveness and maintain its strategic position within the global textile supply chain.

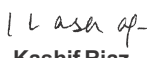

دوران مدت 100.713 ملین روپے مقررہ اثاثوں میں سرمایہ کاری کی گئی جو کہ کھیتی کے معیار کو بہتر بنانے کے لیے BMR پلان کا حصہ ہے۔ اسی مقصد کی مالی اعانت کے لیے برقرار رکھی گئی۔ آمدنی کا استعمال کیا گیا۔

فی شخص آمد ششماہی ۳۱ دسمبر ۲۰۲۵ ختم ہونے پر 1.20 روپے ہے، جبکہ پچھلی اسی مدت میں یہ 15.05 روپے تھی۔

مستقبل کی صورت حال:

پاکستان کے اسپننگ سیکٹر کا مستقبل مجموعی معاشی دباؤ اور ساختی چیلنجز کے باوجود سناٹا طور پر برآمدیہ نظر آتا ہے۔ ٹیکسٹائل و ٹیلیو جین کے ایک بنیادی حصے کے طور پر اسپننگ برآمدی آمدنی اور صنعتی روزگار میں اہم کردار ادا کرتی ہے۔ پاکستان کو تاریخی طور پر مضبوط کپاس کی بنیاد اور بین الاقوامی منڈیوں میں دھاگے کی برآمدات میں مستحکم موجودگی کا فائدہ حاصل رہا ہے۔

تاہم اس شعبے کو نمایاں چیلنجز کا سامنا ہے۔ موہمی تغیرات، کپڑوں کے حملوں اور فصلوں کے بدلنے ہوئے رجحانات کی وجہ سے کپاس کی پیداوار میں مسلسل کمی واقع ہو رہی ہے۔ جس کے باعث درآمدی کپاس پر انحصار بڑھ گیا ہے۔ اس سے پیداواری لاگت میں اضافہ اور منافع کے راجن میں کمی واقع ہوئی ہے۔ مقامی کپاس کے معیار میں عدم یکسانیت بھی دھاگے کے مسابقتی صلاحیت کو متاثر کرتی ہے۔

مزید برآں، عالمی سطح پر ٹیکسٹائل کی طلب میں کمی اور علاقائی پیدا کنندگان جیسے بھارت اور بنگلہ دیش کی مضبوط مسابقت نے دھاگے کی قیمتوں اور برآمدی حجم پر بیچنے کی جانب دباؤ ڈالا ہے۔

توانائی اسپننگ ملوں کے لیے بدستور سب سے اہم رکاوٹوں میں سے ایک ہے۔ بجلی اور گیس کے بلند اور غیر مستحکم ٹیرف، نیز وقتاً فوقتاً سلائی میں قحط، مسابقتی ممالک کے مقابلے میں لاگت کی کارکردگی کو نمایاں طور پر متاثر کرتے ہیں۔ ٹیکس ریفرنڈمز میں تاخیر اور رجائی مالی سہولیات تک محدود درستی کے باعث پیدا ہونے والے لیکویڈیٹی مسائل بھی شدت اختیار کر چکے ہیں۔ جو پورے شعبے میں ورکنگ کپٹل پر مسلسل دباؤ ڈال رہے ہیں۔

ان چیلنجز کے باوجود، کچھ مثبت پیش رفتیں ایسی ہیں جو طویل المدتی امکانات کو بہتر بنا سکتی ہیں۔ بہت سے اسپننگ پلانٹس جدید توانائی سے مشغول مشینری اور قابل تجدید توانائی کے عمل، جیسے شمسی توانائی، میں سرمایہ کاری کر رہی ہیں۔ تاکہ پری ٹینگ لاگت کم کی جاسکے اور پیداواری صلاحیت میں اضافہ ہو۔ اسی طرح بہتر قدر کے حصول اور عام یا کم قیمت والے حصوں پر انحصار کم کرنے کے لیے ایلی میٹیا اور خصوصی نوعیت کے دھاگوں کی طرف تدریج منتقلی بھی دیکھنے میں آ رہی ہے۔

مستقبل کو مٹی پالیسیوں، توانائی کے ٹیرف کی معقول تشکیل، کپاس کی پیداوار میں بہتری، دیکنا لوجی کی مسلسل اپ گریڈیشن کے ساتھ، پاکستان کا اسپننگ سیکٹر اپنی مسابقتی صلاحیت کو مزید مضبوط بنانے اور عالمی ٹیکسٹائل سپلائی چین میں اپنی اسٹرٹیجک حیثیت برقرار رکھنے کی بھرپور صلاحیت رکھتا ہے۔

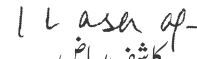

INDEPENDENT AUDITORS' REVIEW REPORT

To the members of Sunrays Textile Mills Limited

Report on the Review of Unconsolidated Interim Financial Statements

Introduction

We have reviewed the accompanying unconsolidated condensed interim statement of financial position of **Sunrays Textile Mills Limited** (the Company) as at December 31, 2025 and the related unconsolidated condensed interim statement of profit or loss, unconsolidated condensed interim statement of comprehensive income, unconsolidated condensed interim statement of changes in equity, unconsolidated condensed interim statement of cash flows, and notes to the financial statements for the six month period then ended (here-in-after referred to as the "interim financial statements"). Management is responsible for the preparation and presentation of these unconsolidated condensed interim financial statements in accordance with accounting and reporting standards as applicable in Pakistan for interim financial reporting. Our responsibility is to express a conclusion on these unconsolidated condensed interim financial statements based on our review.

Scope of Review

We conducted our review in accordance with International Standard on Review Engagements 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity". A review of interim financial statements consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with International Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the accompanying interim financial statements are not prepared, in all material respects, in accordance with the accounting and reporting standards as applicable in Pakistan for interim financial reporting.

Other Matter

Pursuant to the requirement of Section 237 (1) (b) of the Companies Act, 2017, only cumulative figures for the six-month, presented in the second quarter accounts are subject to a limited scope review by the statutory auditors of the company. Accordingly, the figures of the unconsolidated condensed interim statement of profit and loss and unconsolidated condensed interim statement of comprehensive income for the three months period ended December 31, 2025 have not been reviewed by us.

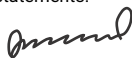

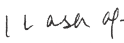

NOTES TO THE UNCONSOLIDATED INTERIM FINANCIAL STATEMENT FOR THE SIX MONTH PERIOD ENDED DECEMBER 31, 2025

1. LEGAL STATUS AND OPERATIONS

- 1.1 Sunrays Textile Mills Limited ("the Company") was incorporated in Pakistan on August 27, 1987 as a public limited company under the repealed Companies Ordinance, 1984 (Now Companies Act 2017) and its shares are quoted on the Pakistan Stock Exchange. The Company is principally engaged in trade, manufacture and sale of yarn. The registered office of the Company is situated at Office no. 508, 5th floor, Beaumont Plaza, Beaumont Road, Civil Lines Quarters, Karachi. The area of the mill is 114 kanals and 10 marlas, and is located at Khanpur Shumali khewat no. 359, District Muzaffargarh, Dera Ghazi Khan Division, in the province of punjab.
- 1.2 These financial statements are the separate financial statements of the Company in which investment in subsidiary companies is accounted for on the basis of actual cost less impairment, if any. Consolidated financial statements are prepared separately.
- 1.3 These interim financial statements are presented in Pak Rupees, which is the Company's functional and presentation currency.

2. MATERIAL ACCOUNTING POLICY INFORMATION

2.1 Statement of compliance

These interim financial statements of the Company have been prepared in accordance with the accounting and reporting standards as applicable in Pakistan for interim financial reporting. The accounting and reporting standards as applicable in Pakistan for interim financial reporting comprise of:

- International Accounting Standard (IAS) 34, Interim Financial Reporting, issued by the International Accounting Standards Board (IASB) as notified under the Companies Act, 2017 ; and

- Provisions of, directives and notifications issued under the Companies Act, 2017.

Where the provisions of, directives and notifications issued under the Companies Act, 2017 differ with the requirements of IAS 34, the provisions of, directives and notifications issued under the Companies Act, 2017 have been followed.

- 2.2 These interim financial statements are un-audited but subject to limited scope review by auditors and are being submitted to the shareholders as required under Section 237 of the act.
- 2.3 These unconsolidated condensed interim financial statements do not include all information required for full unconsolidated annual financial statements and should be read in conjunction with unconsolidated annual audited financial statements for the year ended June 30, 2025. Comparative unconsolidated condensed interim statement of financial position has been extracted from unconsolidated annual audited financial statements for the year ended June 30, 2025 whereas comparative unconsolidated condensed statement of profit or loss and unconsolidated condensed interim statement of comprehensive income, comparative unconsolidated condensed interim statement of changes in equity and comparative unconsolidated condensed interim statement of cash flows has been extracted from un-audited unconsolidated condensed interim financial statements for the six month period ended December 31, 2024

2.4 MATERIAL ACCOUNTING POLICY INFORMATION, ESTIMATES AND JUDGEMENTS.

The accounting policies and the methods of computation adopted in the preparation of this unconsolidated condensed interim financial information and the significant judgements made by the management in applying the accounting policies and the key sources of estimation uncertainty are the same as those applied in the preparation of the unconsolidated financial statements as at and for the year ended June 30, 2025. Certain new IFRS standards and amendments to existing IFRS Accounting standards are effective for periods beginning on or after July 1, 2025, which do not have any impact on the Company's financial reporting and therefore, have not been detailed in this condensed interim financial statements.

- Level 2: Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derive from prices).
- Level 3: Inputs for asset or liability that are not based on observable market data (unobservable inputs)

13.1 Fair value of property, plant and equipment and other financial assets

The Company has its freehold land, building on freehold land and plant and machinery revalued on June 30, 2025 by M.Y.K Associates (Private) Limited and Joseph Lobo (Private) Limited. Both are independent valuer not connected with the Company. The basis used for the revaluation of of these assets were as follows:

Freehold land

Fair market value of the land was assessed through inquiries in the vicinity of land, recent market deals and information obtained through estate agents and property dealers of the area.

Building on freehold land

Fair market value of the building was assessed mainly through new construction value, depreciation cost factors, state of infrastructure, current trends in prices of real estate in the vicinity and information obtained through estate agents, builders and developers.

Plant and machinery and electric installations

Fair market value of the plant and machinery and electric installations was assessed through inquiries of local authorized dealers who deal in old and new similar type of plant and machineries. Replacement value was then ascertained from competitive rates of the plant and machinery and electric installations and thereafter, an average depreciation factor was applied on the replacement value of the plant and machinery and electric installations.

Short term investments

Short term investments include quoted equity shares, mutual funds, term finance certificate and term deposit receipt. The equity share and funds are valued at each reporting date at their fair value by using the prevailing quoted prices of shares on Pakistan Stock Exchange Limited. Term finance certificate and term deposit receipt are valued at amortized cost.

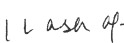

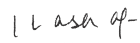

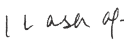

**NOTES TO THE CONSOLIDATED INTERIM FINANCIAL
STATEMENT
FOR THE SIX MONTH PERIOD ENDED DECEMBER 31, 2025**

1. THE GROUP AND ITS OPERATIONS

The Group consists of Sunrays Textile Mills Limited (the Holding Company) and Embee Industries (Private) Limited (Subsidiary). Brief profile of the Holding Company and Subsidiary are as follows:

1.1 Sunrays Textile Mills Limited

Sunrays Textile Mills Limited "the Company" was incorporated in Pakistan on August 27, 1987 as a public limited company under the repealed Companies Ordinance, 1984 (Now Companies Act 2017) and its shares are quoted on the Pakistan Stock Exchange. The Company is principally engaged in trade, manufacture and sale of yarn. The registered office of the Company is situated at Office no. 508, 5th floor, Beaumont Plaza, Beaumont Road, Civil Lines Quarters, Karachi. The mill site is located at Khanpur Shumali khewat no. 359, District Muzaffargarh, Dera Ghazi Khan Division, in the province of Punjab having area of 727 Kanal and 10 Marlas.

1.2 Embee Industries (Private) Limited

Embee Industries (Private) Limited (the company) was incorporated in Pakistan under the repealed Companies Ordinance, 1984 (now the Companies Act, 2017) as a private limited company on 16th April, 1985. The principal business of the Company is manufacturing and sale of ice. The registered office and works of the company are located at Riaz Cotton Factory, Factory Area, Faisalabad in the province of the Punjab. The company became fully owned subsidiary of Sunrays Textile Mills Limited. The company has rented out its land and building and is not in manufacturing operations.

1.3 Basis of Consolidation

The consolidated financial statements include the financial statements of the Holding Company and its subsidiary.

Subsidiary company is fully consolidated from the date on which more than 50% of voting rights are transferred to the Group or power to control them is established and excluded from consolidation from the date of disposal or when the control is lost.

The financial statements of the subsidiary are prepared for the same reporting year as of the Holding Company for the purpose of consolidation, using consistent accounting policies. The accounting policies of the subsidiaries have been changed to conform with accounting policies of the Group, where required.

The assets, liabilities, income and expenses of subsidiary companies are consolidated on a line by line basis and carrying value of investments held by the Holding Company is eliminated against the subsidiary companies' shareholders' equity in these consolidated All intra-group balances, transactions and unrealised gains and losses resulting from intra-group transactions and dividends are eliminated in full.

2. MATERIAL ACCOUNTING POLICY INFORMATION

2.1 Statement of compliance

These interim financial statements of the Company have been prepared in accordance with the accounting and reporting standards as applicable in Pakistan for interim financial reporting. The accounting and reporting standards as applicable in Pakistan for interim financial reporting comprise of:

International Accounting Standard (IAS) 34, Interim Financial Reporting, issued by the International Accounting Standards Board (IASB) as notified under the Companies Act, 2017; and

Provisions of, directives and notifications issued under the Companies Act, 2017.

Where the provisions of, directives and notifications issued under the Companies Act, 2017 differ with the requirements of IAS 34, the provisions of, directives and notifications issued under the Companies Act, 2017 have been followed.

- 2.2** These interim financial statements are un-audited but subject to limited scope review by auditors and are being submitted to the shareholders as required under Section 237 of the act.
- 2.3** These consolidated condensed interim financial statements do not include all information required for full consolidated annual financial statements and should be read in conjunction with consolidated annual audited financial statements for the year ended June 30, 2025. Comparative consolidated condensed interim statement of financial position has been extracted from consolidated annual audited financial statements for the year ended June 30, 2025 whereas comparative consolidated condensed statement of profit or loss and consolidated condensed interim statement of comprehensive income, comparative consolidated condensed interim statement of changes in equity and comparative consolidated condensed interim statement of cash flows has been extracted from un-audited consolidated condensed interim financial statements for the six month period ended December 31, 2024.
- 2.4 MATERIAL ACCOUNTING POLICY INFORMATION, ESTIMATES AND JUDGEMENTS.**
The accounting policies and the methods of computation adopted in the preparation of this consolidated condensed interim financial information and the significant judgements made by the management in applying the accounting policies and the key sources of estimation uncertainty are the same as those applied in the preparation of the consolidated financial statements as at and for the year ended June 30, 2025. Certain new IFRS standards and amendments to existing IFRS Accounting standards are effective for periods beginning on or after July 1, 2025, which do not have any impact on the Company's financial reporting and therefore, have not been detailed in this condensed interim financial statements.

13. FAIR VALUE MEASUREMENTS

IFRS 13 requires fair value measurement disclosures using following three level fair value hierarchy that reflects the significance of the inputs used in measuring fair value of financial Instruments. Information about fair value hierarchy and asset classified under the hierarchy as follows.

- Level 1: Quoted prices (unadjusted) in active market for identical assets or liabilities.
- Level 2: Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derive from prices).
- Level 3: Inputs for asset or liability that are not based on observable market data (unobservable inputs).

13.1 Fair value of property, plant and equipment and other financial assets

The Company has its freehold land, building on freehold land and plant and machinery revalued on June 30, 2025 by M.Y.K Associates (Private) Limited and Joseph Lobo (Private) Limited. Both are independent valuer not connected with the Company. The basis used for the revaluation of these assets were as follows:

Freehold land

Fair market value of the land was assessed through inquiries in the vicinity of land, recent market deals and information obtained through estate agents and property dealers of the area.

Building on freehold land

Fair market value of the building was assessed mainly through new construction value, depreciation cost factors, state of infrastructure, current trends in prices of real estate in the vicinity and information obtained through estate agents, builders and developers.

Plant and machinery and electric installations

Fair market value of the plant and machinery and electric installations was assessed through inquiries of local authorized dealers who deal in old and new similar type of plant and machineries. Replacement value was then ascertained from competitive rates of the plant and machinery and electric installations and thereafter, an average depreciation factor was applied on the replacement value of the plant and machinery and electric installations.

Short term investments

Short term investments include quoted equity shares, mutual funds, term finance certificate and term deposit receipt. The equity share and funds are valued at each reporting date at their fair value by using the prevailing quoted prices of shares on Pakistan Stock Exchange Limited. Term finance certificate and term deposit receipt are valued at amortized cost.

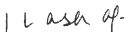
