Atlas Honda Limited (the Company), a joint venture of Atlas Group and Honda Motor Company, is pleased to announce an investment plan for the expansion of its motorcycle operations in Pakistan. During the Board Meeting held on 30<sup>th</sup> March 2026, the Board approved a Capital Expenditure of Rs 5.3 Billion (approximately USD 20 million) for the next financial year. The investment will be made to enhance capacity, automation and productivity. As a result, the Company's rated annual capacity will increase to 2 million units.


