

Dar chairs meeting on Discos' privatisation

ISLAMABAD: Deputy Prime Minister and Foreign Minister (DPM/ FM) Senator Muhammad Ishaq Dar chaired a meeting of the Steering Committee overseeing the privatisation of power distribution companies (Discos) on Friday. The Committee was briefed by Advisor Privatisation on the latest position and the progress achieved on Hatch-Discos (HESCO, FESCO & GEPCO). It expressed satisfaction and advised the privatisation Commission to complete the process within the agreed timelines. DPM/ FM emphasised that while privatisation aims to improve efficiency, service delivery, and financial sustainability, a strong regulatory framework and effective oversight will remain essential to protect consumers' interests, ensure transparency, and uphold accountability.

Six terrorists killed in Panjgur IBO

ISLAMABAD: Security forces killed six terrorists linked to what the military described as the Indian proxy group "Fiza al Hindistan" during an intelligence-based operation (IBO) in Balochistan's Panjgur district. According to the Inter-Services Public Relations (ISPR), the operation was conducted on the night of June 3-4 after receiving intelligence regarding the presence of terrorists in the area. During the operation, security forces effectively engaged multiple terrorist hideouts and, after an intense exchange of fire, killed six terrorists. The ISPR said weapons, ammunition, improvised explosive devices (IEDs) and a vehicle were recovered from the slain terrorists, who were allegedly involved in numerous terrorist activities in the area. Security operations were continuing to eliminate any remaining terrorists in the vicinity.
