Re: Order of the United States District Court in New York

In accordance with Section 96 of the Securities Act, 2015 and Clause 5.6.1(a) of the Rule Book of the Pakistan Stock Exchange Limited, we hereby convey the following information:

TRG Pakistan Limited (the “Company”) has received a copy of an order issued on 1 July 2026 (the “Order”) by the United States District Court for the Southern District of New York (“SDNY”) where the SDNY has declined to grant the injunctive relief requested by the Company and The Resource Group International Limited subsequent to the Temporary Restraining Order against the Company’s former CEO, Mr. Zia Chishti, received on 10 June 2026, which expired on 1 July 2026. The requested injunctive relief included enjoining certain litigation proceedings initiated by Mr. Chishti in Pakistan against the Company and its affiliates.

The Order is limited to the Company’s request for injunctive relief under the legal standard relevant to such injunctions and does not alter the 12 May 2026 ruling of SDNY (the “12 May Ruling”), which concluded that claims by Mr. Chishti against the Company and its affiliates relating to actions undertaken prior to the 10 January 2022 date of the Release Agreement are forever released and cannot be adjudicated in any forum worldwide. The 12 May Ruling remains in effect and has been appealed by Mr. Chishti in the Second Circuit Court of Appeals in New York (the “Second Circuit”).

The Company continues to review its legal options in light of this development, including appealing the Order with the Second Circuit.
