Subject: Material Information - Intimation of Dismissal of Civil Appeal No. 376/2025 (TRG Pakistan Limited vs. Jahangir Siddiqui & Co. Ltd. & Others) in relation to Civil Suit No. 1696/2025 (old H.C Suit No. 1589 of 2022)

JS Bank Limited (“JSBL” and/or “the Bank”) is pleased to announce an update to its shareholders and the market regarding a significant legal development.

This matter pertains to the litigation initiated by TRG Pakistan Limited (“TRGPL”) against JSBL and other parties in the case titled “TRG Pakistan Limited & Others vs. Jahangir Siddiqui and Co. Ltd. & Others” through Civil Suit No. 1696/2025 (old H.C Suit No. 1589 of 2022). The previous disclosures include our PSX announcement (Ref: JSBL/CSD/2025/12-05) dated December 5, 2025, regarding the order of the Honourable VIth Senior Civil Judge, Karachi - South in the aforementioned suit, and a subsequent PSX disclosure by TRG on December 15, 2025, regarding their filing of Civil Appeal No. 376/2025.

In this regard, we hereby notify you that the Honourable XIIth Additional District Judge / Model Civil Appellate Court, Karachi - South, has issued a judgment dated July 01, 2026, dismissing Civil Appeal of TRGPL vide No. 376/2025. In doing so, the Appellate Court has upheld the original order dated December 02, 2025, which rejected the plaint of TRGPL in Civil Suit No. 1696/2025 under Order VII Rule 11 of the Code of Civil Procedure, 1908.

This verdict validates the Bank’s position that the claims brought against it were without legal merit, frivolous, and filed in bad faith. Importantly, the proceedings resulted in no adverse findings or instructions against the Bank, its parent organization, or its leadership.

JSBL remains committed to transparency and will continue to keep stakeholders informed of matters affecting the Bank’s interests and reputation.
