Reason for not being able to hold the AGM and justification for extension in the period to the extent applied for:	The Company anticipates that the annual accounts for the year ended June 30, 2026, cannot be finalized within the prescribed period, as TPL Corp Limited forms part of the TPL Group, comprising more than eighteen (18) subsidiaries and associated companies, the majority of which also have a financial year ending on June 30. Consequently, the auditors and the finance department's resources are concurrently engaged at the Group level in the audit and finalization of the accounts of various Group entities. As the audit process has progressed, the Company anticipates that it may not be in a position to place the duly audited annual accounts before its shareholders within the stipulated period, despite the concerted efforts of both the auditors and the Company to finalize the accounts in time for circulation of the notice of the Annual General Meeting ("AGM") at least twenty-one (21) days prior to the meeting, i.e., by October 7, 2026, together with the accounts of other listed subsidiaries and associated companies. In light of the foregoing, we respectfully request the Commission to condone the delay and grant an extension of time for holding the AGM until November 27, 2026, under Section 132 of the Companies Act, 2017.

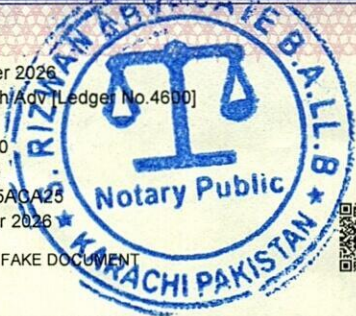

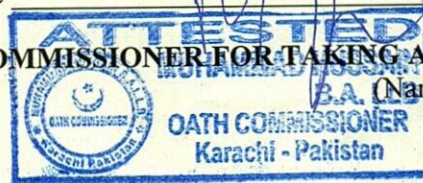

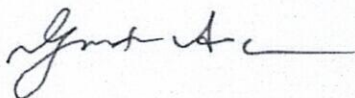
