
In accordance with the requirements of the Rule Book of Pakistan Stock Exchange and applicable provisions of Securities Act, 2015, we would like to inform you that the Board of Directors of the Company in its meeting held on May 31, 2023 at 11:30 a.m. through video conferencing, have recommended the following:

1. To increase the authorized share capital of the Company from Rs.800,000,000 divided into 80,000,000 Shares of Rs. 10/- each, comprising 80,000,000 Ordinary Shares to Rs. 2,800,000,000 divided into 280,000,000 Shares of Rs. 10/- each and consequent alteration in Memorandum and Articles of Association of the Company through special resolution subject to approval of shareholders.
2. To alter the provisions of Articles of Association relating to capitalization of reserves through special resolution, subject to approval of shareholders.
3. To obtain approval/consent of the shareholders in forthcoming EOGM pursuant to the provisions of SRO No. 389(I)/2023 dated March 21, 2023 issued by Securities and Exchange Commission of Pakistan for circulation of Company's annual audited financial statements through QR enabled code and weblink.
4. To hold Extra Ordinary General Meeting (EOGM) of the Members of the Company on Thursday, June 22, 2023 at 01:30 pm at the registered office of the Company, to consider and approve the aforementioned businesses.
5. The Share Transfer Register will remain closed from June 16, 2023 to June 22, 2023 (both days inclusive) and no transfer will be registered during that time Transfers received in order at our Share Registrar M/S CDC House, 99-B, Block B, SMCHS, Main Shahra-e-Faisal, Karachi-74400 at the close of business on June 15,2023 shall be treated in time for the purpose of attending EOGM.

The notice of Extra Ordinary General Meeting of the Company will be sent in due course.
