SUBMISSION OF 1<sup>ST</sup> QUARTER ACCOUNTS OF THE COMPANY  
FOR THE PERIOD ENDED SEPTEMBER 30, 2023**

Dear Sir,

Please refer to our letter No. ACC-501-017-23 dated October 17, 2023 and approval granted by the Commission vide letter No.SMD/PRDD/Comp/(13)/2021/89 dated October 25, 2023 for extension of 30 days i.e up to November 29, 2023 to submit accounts for the quarter ended September 30, 2023 under the provisions of Section 237 of the Companies Act, 2017.

We further refer to Commission's letter No. SMD/PRDD/Comp/(13)2021/100 dated November 15, 2023 granting extension to the Company for holding of Annual General Meeting and laying of Accounts therein for the year ended June 30, 2023. In the aforementioned letter Company was directed in terms of Section 147 of the Act to convene its overdue AGM for the year ended June 30, 2023 by April 15, 2024 and to lay therein Accounts for the year ended June 30, 2023 for shareholders' consideration.

SECP and IAS-34 (Interim Financial Reporting) require that interim reports shall include interim financial statements (condensed or complete) and comparative figures of immediately preceding financial year be mentioned at appropriate place, which in our case are provisional and unaudited till date. In this respect, it is apprised that the audit of accounts for FY 2022-23 has not yet been completed and upon completion of audit the company will file the Final Revenue Requirement (FRR) with OGRA, after determination of which the Financial Statements will be finalized by incorporating the decision of Oil and Gas Regulatory Authority (OGRA) with respect to the FRR.

In the absence of FRR for FY 2022-23 and approval of Financial statements from Company's BOD, the opening balance sheet figures for 1st quarter ended September 30, 2023 would be based on provisional figures which can materially change, once the Final Revenue Requirements are finalized by OGRA. Accordingly, the opening audited balances for the FY 2023-24 for preparation of 1<sup>st</sup> quarterly accounts i.e. September 30, 2023 would be available after the Financial Statements for the year ended June 30, 2023 are approved by BOD and disseminated to Pakistan Stock Exchange (PSX) and other stakeholders.

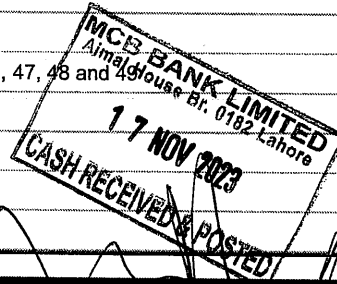
