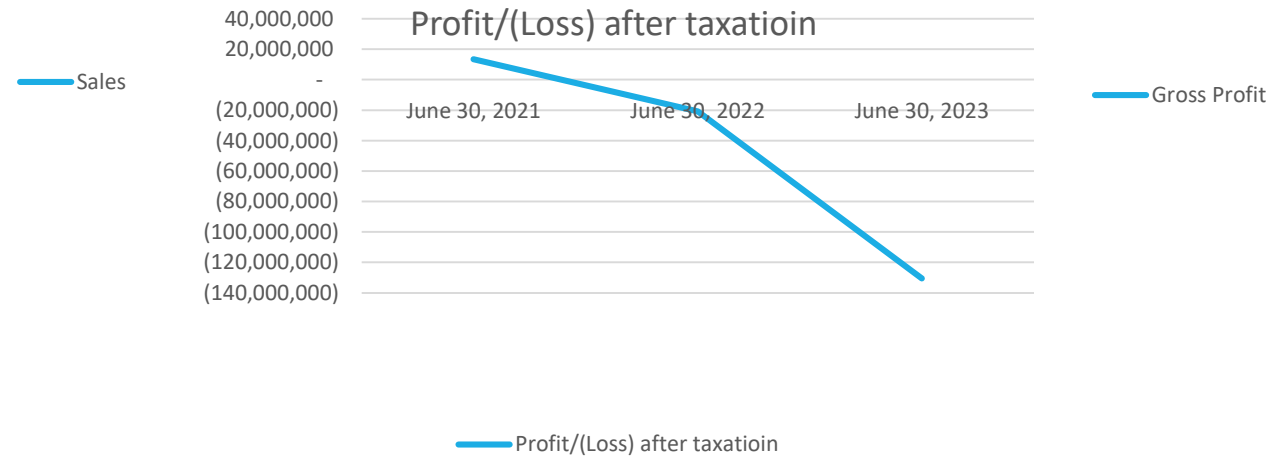
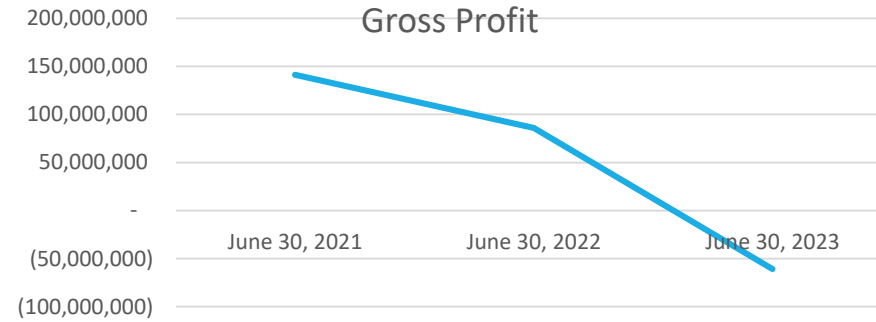
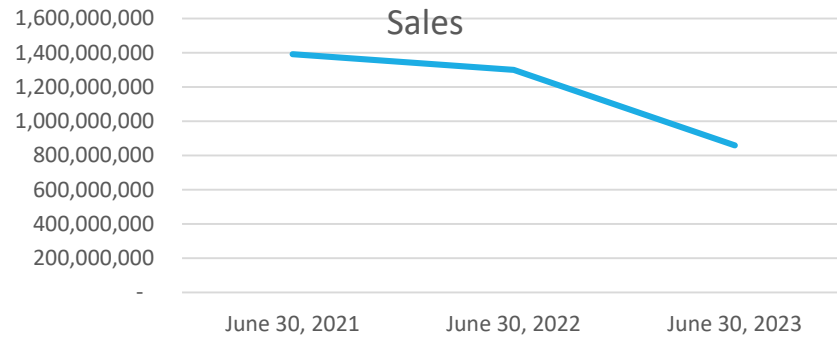
Company recorded sales of Rs. 857,996,198 in the last financial year however, the Company struggled with high cost of doing business in the last quarter
