In continuation to our earlier letter bearing No. SBL/Secy/PSX/24/20 dated 31 January 2024 through which financial results for the year ended 31 December 2023 were announced.

We hereby notify that the Share Transfer Books of the Bank will remain closed from **01.03.2024 to 08.03.2024 (both days inclusive)**. Transfers received by the Share Registrar M/s. THK Associates (Pvt.) Ltd, Plot No.32-C, Jami Commercial Street 2, DHA Phase VII, Karachi at the close of business on **Thursday, 29.02.2024** will be treated in time for the purpose of payment of 30% cash dividend as announced by the Board in their 202<sup>nd</sup> meeting convened on 31 January 2024.

**Payment of Cash Dividend through Electronic Mode (Mandatory)**


In terms of Section 242 of the Act and Companies (Distribution of Dividends) Regulations, 2017, every listed company is required to pay dividend to their shareholders compulsorily through electronic mode by directly crediting the same in their bank account.

In this respect, the Bank has previously communicated this requirement to the shareholders individually along with newspaper publications requesting to provide the 24-digits International Bank Account Number ("IBAN"); however response from very few shareholders was received.

Shareholders are again requested to update their record. In this connection, CDC shareholders may submit their IBAN details to their investor account services or their brokers where shares are placed electronically. In case of physical holding, the shareholders are requested to submit their bank mandate details to the Bank's Share Registrar. For providing the Bank Mandate details to CDC/Share Registrar, the requisite form may be downloaded from the Bank's website, direct link of which is: <https://soneri-bank.nyc3.cdn.digitaloceanspaces.com/wp-content/uploads/2023/08/26093246/Bank-Mandate-Form-1.pdf>.
