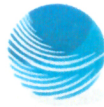

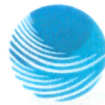

It is reported pursuant to Section 109 of the Securities Act, 2015 read with regulation 4 of the Listed Companies (Substantial Acquisition of Voting Shares and Takeovers) Regulations, 2017, that we, Hallmark Company Limited, have acquired on 27 March 2024, 62,956,672 (Sixty Two Million Nine Hundred Fifty-Six Thousand Six Hundred Seventy Two) i.e. 51% shares of Supernet Limited at the rate of PKR 13.06/- (Pak Rupees Thirteen and Six Paisa) per share, pursuant to the Share Purchase Agreement dated 15 February 2024. This transaction does not attract Part IX of the Act (except reporting) in terms of section 109(1)(h)(iii) of the Act.
2. Before this acquisition we were holding no shares i.e. 0% shares of the company. After abovementioned acquisition our total shareholding in the company is 62,956,672 (Sixty-Two Million Nine Hundred Fifty-Six Thousand Six Hundred Seventy-Two) shares, which represents 51% of the total issued voting shares of the company.

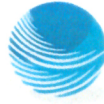
